| → To secure your booking this booking form should be signed and emailed to us with a 50% deposit. Please contact us if you require a postal address. |
| → In the event of you having to cancel your event the deposit is non-refundable. |
| → Should your event not be able to go ahead due to covid restrictions will we be happy to postpone to a mutually agreed date. |
| → Full payment must reach us 2 months prior to booking along with the damages deposit of £200. |
| → The damages deposit will be refunded within 7 days of your booking subject to any damages or costs being incurred. |
| Additional Services |
| → Loos are compulsory with all bookings and should be booked through The Party Field. This can be done through a separate booking form. |

| → Marquees and Tipi's must be sourced through The Party Field from one of our approved suppliers (details can be found on our website www.thepartyfield.co.uk). The use of other suppliers for these services can only be arranged with prior consent from The Party Field and will be subject to an additional fee of £250.00. |

| → For health and safety, only logs purchased from The Party Field can be used on the Campfire. |
| → If the event that straw bales are broken and left unusable an additional charge of £5 per broken bale will be taken from the damages deposit. |
| Arrivals and departures: |
| → You will have access to the site between 9:30am on Friday, until 3 pm on Sunday. Access outside these hours can be arranged but only with prior agreement. |
| → When you leave the site, it must be cleared of all rubbish. (Please let us know if you require a skip). |
| Music Policy |
| → If you wish to play amplified music, whether it be for an Ipod playlist, DJ or band, the PA system must be hired through The Party Field's preferred supplier. The specification of the system is available on request. |
| → All amplified music must be turned off by 11pm. We welcome silent discos from 11pm or acoustic music (except drums) around the campfire (we can arrange either of these services on your behalf, please ask for details). |
| → Amplified music must only be played in a Marquee or Tipi and should only be played on 1 night of your stay (i.e. Friday or Saturday). |
